- ☐ **Direct Deposit Form** - Make sure you sign the Direct Deposit Form and provide your payroll department's address, e-mail, and phone number. We'll get your payroll deduction started immediately!

**2 PROVIDE IDENTIFICATION:**

- ☐ **Identification** - Please provide a legible copy of one of the following: your current Driver's License (or State-Issued ID), Passport, U.S. Armed Forces ID, or permanent Resident Alien Card.
- ☐ **Recent Paycheck Stub** - Please provide a copy of a recent paycheck stub to assist us in setting up your direct deposit and verify your teamster affiliation. (If you don't have a paycheck stub available, we can confirm with your local.)

**3 MAKE YOUR OPENING DEPOSIT:**

- ☐ **New Savings Account** - Make check payable to NETFCU for \$5.00 to get started.  
(Waived with direct deposit!)
- ☐ **New Checking Account** - Make check payable to NETFCU for \$50.00 to get started.  
(Waived with direct deposit!)

## WHAT TO EXPECT NEXT

- 1 RECEIVE YOUR WELCOME KIT** within 2-3 days of opening your account.
  - Welcome Letter/ Getting Started
  - Member Services Brochure
  - Fee Schedule
  - All About Your Account Disclosure
  - Privacy Policy
  - FAQs
- 2 RECEIVE YOUR VISA ATM/DEBIT CARD** within 14 days of opening your account.
- 3 RECEIVE YOUR PERSONAL IDENTIFICATION NUMBER (PIN)** within 7-14 days of opening your account to activate your VISA ATM/Debit Card.
- 4 RECEIVE YOUR FREE CHECK ORDER** within 14 days of opening your account.

In accordance with section 326 of the USA PATRIOT Act of 2001, New England Teamsters Federal Credit Union (NETFCU) is required to obtain a copy of the documents used in identifying our new account customers and in identifying signatory individuals added to an existing or new account. In some cases, identification will be requested for those individuals banking with the credit union prior to the effective date of the customer identification requirements because original documentation was not obtained with the opening of the account, or the Credit Union is unable to form a reasonable belief that it knows the identity of the existing customer. In all cases protection of our customer's identity and confidentiality is the Credit Union's pledge to you. This notice is being provided to you as notice given under this act.
